



**BAC RESOLUTION DECLARING LOWEST CALCULATED RESPONSIVE BID

WHEREAS, the Mines and Geosciences Bureau (MGB) XII posted the Request for Quotation (RFQ) for the Procurement of Office Equipment P.R. No.: 03-018-2018 in the Phil-GEPS website for (8) eight calendar days with an Approved Budget Contract of Php 128,000;

WHEREAS, no bidders signified interest to supply the aforementioned office equipment (Air-condition Unit);

WHEREAS, the MGB personnel conducted an alternative mode of procurement through Shopping and sent Request for Quotation to (3) three potential bidders namely: **QUALITY APPLIANCE PLAZA INC., EMCOR, INC. AND MELGENE AIRCON MKTG. AND SERVICES** to submit price quotations;

WHEREAS, upon opening of bid price quotations on May 7, 2018, and thorough evaluation of all documents submitted, the contract could be awarded to MELGENE AIRCON MKTG. AND SERVICES, as the supplier met the specification required in the request for quotation and as the lowest calculated bid for the Office Equipment as shown in the table below;
