



**BAC RESOLUTION DECLARING FAILURE OF BIDDING ON THE
PROCUREMENT OF VEHICLE RENTAL (BUS FOR GAD GST, KATROPA &
TEAM BUILDING)
RESOLUTION NO. 14**

WHEREAS, the Mines and Geosciences Bureau (MGB) XII posted the Request for Quotation (RFQ) for the PROCUREMENT OF VEHICLE RENTAL (BUS FOR GAD GST, KATROPA & TEAM BUILDING) P.R. No.: 03-024-2018 in the Phil-GEPS website for (8) eight calendar days with an Approved Budget Contract of Php 35,000.00;

WHEREAS, in response to the said advertisement, there were no bidders who signified the interest to supply the aforementioned Vehicle (BUS FOR GAD GST, KATROPA & TEAM BUILDING);

WHEREAS, the MGB personnel conducted an alternative mode of procurement through Shopping and sent Request for Quotation to (3) three potential bidders namely: **YELLOWBUS LINE INC., HUSKY TOURS AND MINDANAO STARS** to submit price quotations;

WHEREAS, on the basis of the bid price quotations submitted by two (2) the above-mentioned bidders and considering that their prices fall within the amount allocated for the items specified in the RFQ, the MGB-XII-BAC found **YELLOWBUS LINE INC., HUSKY TOURS**, are qualified;

WHEREAS, upon opening of bid price quotations on March 15, 2018, and thorough evaluation of all documents submitted MGB-XII-BAC found **YELLOWBUS LINE INC.** and **HUSKY TOURS** is not able to reach the service needed. Due to high cost of bus rental, the bus was finally ruled out and submitted RFQ's nullified. BAC decided to conduct canvass again for 3 Vans.;

NOW, THEREFORE, we, the members of the BAC, do hereby **UNANIMOUSLY DECLARES THE FAILURE OF BIDDING ON THE PROCUREMENT OF VEHICLE RENTAL (BUS)**;




